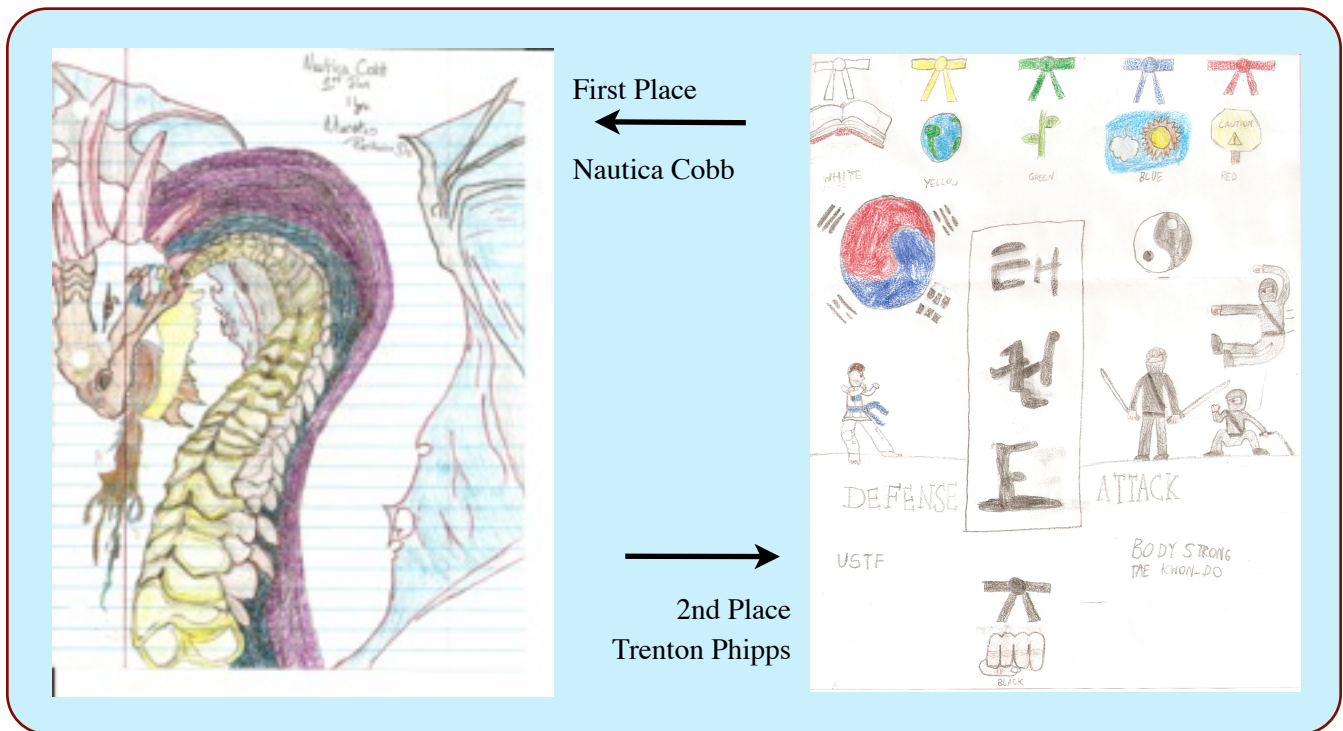

There will be a USTF Referee Course at Sereff Taekwon-Do on January 25.

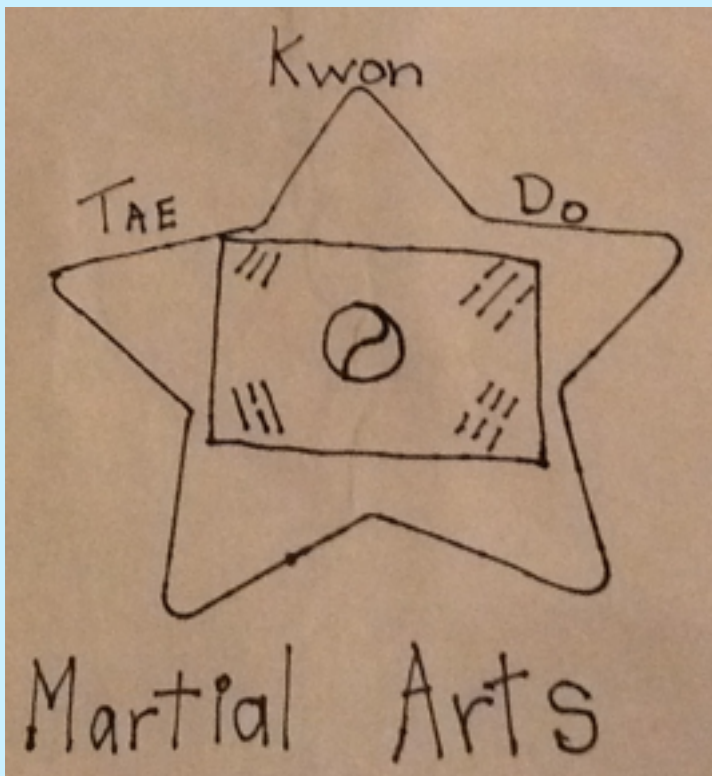
A tentative USTF Instructor “C” course will be February 8 and 9 in Broomfield.
