

A LETTER FROM SOUTH AFRICA

As I prepare to depart Southern Africa after five years as the USFWS Law Enforcement Attaché in the region, I am having to say goodbye to some good friends and colleagues in various African police agencies. Although I'm sorry to see this adventure end, I'm looking forward to being back in the US. My five years in Southern Africa has gone by too quickly. I've had some notable successes and some notable failures in our ongoing battle to help the world combat international wildlife crimes involving African species. Right now, I'm

scheduled to return to the Los Angeles field office of the US Fish and Wildlife Service, Office of Law Enforcement. Earlier this week, with proper social distancing, I joined my friend Lieutenant Colonel Steve Roets and his wife for a goodbye dinner. Before I left their house in Pretoria, he gave me this cool patch from his South Africa Police Service unit. In 2015, shortly after I arrived in Africa, I met Steve and we immediately hit it off. He treated me as a fellow law enforcement officer and not as an American intruding on his turf. We developed a strong professional relationship and friendship and he helped me on many occasions as I tried to figure out the best way to proceed or the best person to contact about an issue. Steve retired this year after a distinguished career in the SAPS. In 2016, Steve allowed my niece, Molly, who is majoring in wildlife biology at Colorado State



University, to visit a rhino crime scene and showed her how to collect DNA evidence. There are many examples of where I've worked with police officers across the nine countries in my area of responsibility to successfully disrupt wildlife crimes. Africa is a very dangerous place to do wildlife law enforcement and we've lost a few officers over the past five years, including one who I knew and patrolled with in Kruger National Park. It's been an honor to play a very small part in this fight to save our planet's wildlife treasures.
